PUBLIC FORUM Marian Keyworth, Stephen Block, Ren Babington, Bill Cumbelich and

Denny McLeod all urged property owners and the City Council to continue to support the formation of utility undergrounding districts in Piedmont, stressing that such districts improve public safety and community aesthetics. They also requested that the Council relax its current 70% threshold percentage for property owner support necessary to obtain Council approval of district formations, believing that such a super-majority requirement is unfair. Mr. McLeod read a prepared statement setting forth the benefits of the proposed Central Piedmont Utility Undergrounding Assessment District and urged property owner

and Council support of this project on March 5.

REGULAR CALENDAR The Council considered the following items of regular business:

Agreement The Public Works Director recommended Council approval of a proposed agreement with Harris & Associates for the provision of

professional engineering services. He stated that five engineering firms responded to the City's December 2005 "Request for Proposal for Engineering Services" and that Harris & Associates' hourly rates and services were within the median of all the submitted proposals. All five engineering firms were extensively interviewed and evaluated and it was the unanimous recommendation of the interviewing team that Harris & Associates be awarded the contract. The proposed contract is for two years, with two one-year renewal options. Harris & Associates has served as the City's Consulting Engineer since 1984. The Director added that the delay in submitting this recommendation was due to the fact that Vern Phillips who served as City Engineer under the previous contract was transferred out of state and City staff wanted time to evaluate his replacement (Russ Moore) before finalizing its recommendation. City staff is very satisfied with the performance and qualifications of Mr. Moore.

Public testimony was received from:

George Kersh felt that contractor selection in this case was a "done deal" because of Mr. Moore's trial period and as a result, unfair to the other bidders.

At the request of the Mayor, the Director agreed to provide the Council with the total City Engineer costs for 2006 – both general City engineering costs and sewer rehabilitation design costs.

The City Attorney recommended first reading approval of proposed Ordinance 669 N.S. amending various sections of the City Code to provide protection for the City against the expenses and liability relating to CEQA litigation. The ordinance is based on a format used by more and more cities and it specifically makes "defense, indemnification and hold harmless" a condition to approval of planning, wireless communications facility and subdivision applications where CEQA litigation would mostly likely arise.

Public testimony was received from:

George Kersh voiced concern that the proposed ordinance will place the burden of liability on residents/property owners rather than the City in instances involving CEQA overviews.

The Council supported the ordinance in concept, requesting that several "editing" changes be incorporated into the next draft prior to second reading consideration.
