Regular Meeting Minutes for Monday, June 18, 2007

REGULAR CALENDAR

The Council considered the following items of regular business:

Agreement

Based upon Council Closed Session discussions, the Finance Director recommended Council approval of a three-year Memorandum of Understanding with the Recreation/Childcare Employees Group for the positions of Childcare Site/Recreation Program Coordinator and Assistant Childcare Site/Recreation Program Coordinator. The proposed MOU authorizes:

- a 2.56% base salary increase for the first year (effective April 1, 2007) and 2.50% for subsequent years (April 1, 2008 and 2009):
- a cost of living increase of 3.44% for the first year and subsequent increases based upon the Consumer Price Index of the San Francisco-Oakland-San Jose Statistical Metropolitan Area, All Urban Consumers Index, for the one-year periods ending December 31, 2007 and 2008 respectively;
- newly instituted cost sharing provisions for medical benefits;
- children of employees covered by this MOU are eligible to attend Schoolmates at no charge; and
- between April 1, 2007 and March 31, 2010, compensatory time accrual may be cashed out to a maximum of forty hours per year at the discretion of the department head.

Agreement

The Parks & Projects Manager recommended Council approval of a contract with Cottong & Taniguchi in the amount of \$55,000 for landscape architectural services and preparation of construction bid documents for the Exedra Plaza Project, Phase III. Phase III continues the master plan renovation of Piedmont Park, with particular emphasis on the development of a new over-look area at the old bridge site in honor of the late Barbara Magee.

Public testimony was received from:

Sue Herrick, President of the Piedmont Beautification Foundation, urged Council approval of the proposed contract, noting that the Foundation is committed to raising \$100,000 in private funding for Phase III of the Exedra Plaza Project. She stated that approximately \$70,000 for this project has already been raised and there is tremendous community support for the project.
