# PIEDMONT CITY COUNCIL

Regular Meeting Minutes for Monday, April 1, 2019

A Regular Session of the Piedmont City Council was held April 1, 2019, in the City Hall Council Chambers at 120 Vista Avenue. In accordance with Government Code Section 54957(b), the agenda for this meeting was posted for public inspection on March 28, 2019.

**CALL TO ORDER** Mayor Bob McBain called the meeting to order at 7:30 p.m. with the Pledge of

Allegiance.

**PUBLIC FORUM** Tom Walters discussed the Kingston, Lake, Rose and Linda Preferential Parking

District, approved by the Council in October 2017 on a trial basis. He stated the trial period ended July 2018 and Council had received a report on the district in March 2019. He requested that the Council agendize a discussion of the trial

period.

Sunny Bostrom-Fleming announced that the Piedmont Community Church Treasure sale raised \$37,000 to support the annual Mexico service trip to build

homes.

## **CEREMONIAL MATTERS**

Chinese American Veterans of World War II Congressional Gold Medal Proclamation Mayor McBain presented a proclamation recognizing the service of Chinese American Veterans of World War II on the occasion of the award of a Congressional Gold Medal in honor of their service. Mary Geong and Cassindy Chao of the Piedmont Asian American Club thanked the City for recognizing these deserving veterans of World War II.

Proclamation Supporting 2020 United States Census Mayor McBain presented a proclamation recognizing the importance of the 2020 US Census. Shahidah Lacy of Alameda County Supervisor Keith Carson's office thanked the City for issuing this proclamation and discussed the importance of an accurate census count to all levels of government.

Agreement with Alameda County Transportation City Administrator Paul Benoit reported that, based on Council direction, staff worked on plans for design and installation of pedestrian safety railing on both sides of the Oakland Avenue bridge. He explained that the bid estimates were

significantly higher than anticipated and Vice Mayor King had obtained **Oakland Avenue Bridge** supplemental funding through ACTC, in the form of a matching grant of \$218,000 to support the project. He requested Council approval of the project funding agreement and authorize staff to solicit bids.

> Public Works Director Chester Nakahara thanked Vice Mayor King for obtaining the funding. He discussed the importance of the project as part of the Pedestrian Bicycle Master Plan.

Responding to Council inquiries, Mr. Nakahara discussed the design of the proposed railings, safety improvements, and signage. He also discussed proposed future projects in the area, including paving of Oakland Avenue, pedestrian enhancements at Howard and Sunnyside Avenues, painting the bridge, and lighting the underside of the bridge in conjunction with the Linda Beach Master Plan.

The Council acknowledged the importance of this transportation corridor and the improvements which have previously taken place, including lighting. The Council expressed appreciation to the voters of Alameda County and the Alameda County Transportation Commission for the grant funds, which help make this project possible.

There was no **Public Testimony** on the matter.

#### Resolution No. 17-19

WHEREAS, one of the high-priority projects identified in the City's adopted Pedestrian and Bicycle Master Plan is the installation of sidewalk railings on the Oakland Avenue bridge; and

WHEREAS, plans and specifications have been completed for the project and the project is ready to be publicly bid; and

WHEREAS, part of the funding (\$208,000) associated with the project is with Congestion Management Agency (CMA) Transportation Improvement Program (TIP) monies as allocated by the Alameda County Transportation Commission (ACTC); and

WHEREAS, as a condition of using CMA TIP monies, ACTC requires that the City enter into an agreement with ACTC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PIEDMONT AS FOLLOWS:

- 1. The City hereby authorizes the City Administrator to sign the Agreement with ACTC for CMA TIP monies associated with the Oakland Avenue Bridge Pedestrian Railing project.
- 2. The City hereby authorizes the release of the project for public bidding per the Public Contract Code and City Ordinances.
